MINUTES OF THE PARISH COUNCIL MEETING HELD AT 7.30PM AT THE CHAPEL, MAIN STREET, HESSAY ON THURSDAY, 26 JANUARY 2023

We seek assurance that existing hardcore is not contaminated and is suitable for development. We seek assurance that the access to the site will be assessed in line with current highway standards.</p>
